The user may inadvertently enter Metric values into Height and Weight fields labeled with US Standard units.

Scope: MOSAIQ customers using Version 2.0 and higher

Notification Released: September 2019

Description of Problem:

The user may inadvertently enter Metric values into Height and Weight fields labeled with US Standard units.

Details:

The Vitals/Lab Data entry window will be presented if there is missing information when entering a drug order or checking the drug order status. The window will always default to US Standard units the first time the window is opened for each user. Height will have units of inches (in) and Weight will have units of pounds (lbs).

In order to switch the units to Metric, the user must click on the Metric units radio button. Once this is selected, the Height units will change to centimeters (cm) and Weight units will change to kilograms (kg).

Customers who use Metric units in all other parts of the software might not notice the default radio button setting and the units displayed on the Vitals/Lab Data entry window. Metric values are being entered for Height and Weight when US Standard values are expected.

Clinical Impact:

If the units are left defaulted to US Standard, but Metric measurements are entered, the resulting BSA will be much larger than expected. If undetected, a patient could receive a BSA based drug dose higher than necessary.

Recommended User Action:

Be sure to note that the Vitals/Lab Data entry window always defaults to US Standard units the first time the window is opened for each user. Click on the Metric units radio button if Height and Weight are to be entered in centimeters (cm) and kilograms (kg). The units preference is saved per user for each subsequent time the window opens.
