- *Multiple* means at least one is required, multiple are allowed and it cannot be duplicated.
- One means exactly one
- Submission Number of "DMF" applies for any Product Type "DMF".
- Submission Type of *Baseline* (sub-type-18) will have a Submission Number of "Other", unless the Product Type is DMF.
- Submission Type of *Transfer of Application* (sub-type-20) will have a PRISM-type Submission Number, <u>unless</u> the Product Type is DMF.
